CLASSES OF MEMBERSHIP (complete definitions are to be found in the Club's constitution):

Membership:- membership shall be conferred on any person subject to the following conditions:

1. That the person is interested in the objectives of the Club.
 2. That the person is either the registered owner or part owner of any type of Land Rover which is maintained in a roadworthy condition (includes vehicles in the state of reconstruction to roadworthy condition).
 3. All members are entitled to participate in driving events provided they are in possession of a valid driver's licence.
- Ordinary Member:** any person who qualifies for membership and who resides inside Gauteng Province.
 - Country Member:** any person who qualifies for Ordinary Membership but who resides outside Gauteng may become a Country Member. A Country Member shall enjoy the same privileges and rights as an Ordinary Member.
 - Chapter Member:** any person who qualifies for Country Membership, but who wishes to participate in Chapter events. Country members attending more than 2 Chapter events need to join the Chapter.
 - Overseas Member:** any person who qualifies for Ordinary Membership but whose place of residence is other than in Southern Africa may. An Overseas Member shall enjoy the same privileges and rights as an ordinary member.
 - Associate Member:** any person who is interested in the activities of the Club, but who does not qualify for any other membership, may be invited by the Committee to become an Associate Member. An Associate Member shall have no voting rights. If you do not have a Land Rover, you will be classified as an Associate Member.

Note: the spouse or life partner of a member automatically qualifies for Family Membership. Children of members (under the age of 18) automatically qualify for Junior Membership, those over 18 and who are fully employed and wish to participate in events must become members.
